1. CALL TO ORDER, ROLL CALL, PLEDGE OF ALLEGIANCE

Chair Jeff Endres called the meeting to order at 6:30 p.m. Roll call shows Chair Jeff Endres, Commissioners Ashley Ballweg, Jan Barman, Linda Swann, Richard Weiland, and Matt Wright present.

- a. RESIDENTIAL REZONE & CONDITIONAL USE PERMIT FOR AN ACCESSORY BUILDING WITH PLUMBING & A FOOTPRINT LARGER THAN THE PARCEL'S HOME. FRYE, 7401 MILDRED CT.; 0808-081-8450-0

The applicant indicated the proposed accessory building will be used for personal storage, keeping vehicles and trailers, a boat, it would include a workshop area, with 16' walls with a 4' pitch to accommodate 12' doors. The applicant indicated the space would include water, an office and craft room, but no bedrooms nor businesses. The Plan Commission would like to have GEC in attendance at the next meeting to clarify what is and isn't currently permitted in current RH-1 zoning.

- b. RESIDENTIAL REZONE R-1A LEGACY TO SFR TOWNS' ZONING. TOMASELLI, 7432 CTH K; 0808-291-9760-0

The applicant would like to rezone to SFR to build an accessory structure taller than the 12' allowed under R-1A zoning.

- c. REZONE FROM EXCLUSIVE AG TO RESIDENTIAL. BICKLER LIVING TRUST, 6593 BALZER RD.; 0808-362-8600-9

This is the final Farmland Preservation rezone required by the County.

Motion by Commissioner Barman, seconded by Commissioner Wright to rezone to SFR. Motion carried, 6-0.

8. REZONE FROM EXCLUSIVE AG TO RESIDENTIAL. BICKLER LIVING TRUST, 6593 BALZER RD.; 0808-362-8600-9

Motion by Commissioner Ballweg, seconded by Commissioner Wright to rezone parcel 0808-362-8600-9 from A-1(EX) to SFR. Motion carried, 6-0.
