6. CSM & REZONE A 2.2-ACRE LOT AT APPROXIMATELY 5081 CHURCH RD. FROM A-1(EX) TO SFR AND REMAINING 36 ACRES FROM A-1(EX) TO EA

Motion by Commissioner Wright, seconded by Commissioner Wolfe to approve the CSM and rezone from A-1(EX) to SFR and remainder to EA and note on the CSM that it is utilizing one split. Motion carried, 6-0.

7. REZONE FROM C-2 AND R-1 TO SFR: 6188 COUNTY HWY. P

Motion by Commissioner Wolfe, seconded by Commissioner Barman to approve the rezone from C2 and R1 to SFR. Motion carried, 6-0.

8. REZONE FROM C-2 TO COM & DESIGN REVIEW: 7381 DARLIN DR.

The applicants would like to split the parcel in the future. Plan Commissioners would like them to split it now as they design and submit stormwater applications to the county.

Motion by Commissioner Wolfe seconded by Commissioner Weiland to table the commercial rezone project and design review. Motion carried, 6-0.

A number of large land owners received a letter from Acker Living Trust, explaining the TDR program in an effort to increase the number of splits available for sale.
