# **MEETING MINUTES**

Tuesday, June 20, 2023, 7:00 P.M. **Town Board Meeting** 

1. CALL TO ORDER, ROLL CALL, PLEDGE OF ALLEGIANCE The Town Chairman called the meeting to order at 7:00 p.m.

Roll call shows Chairperson Pulvermacher and Supervisors Art Meinholz, and Leon Zinck III present; Supervisor Matt Wright was absent. Sup. Laufenberg arrived at 7:04 p.m.

Also present were Clerk-Treasurer Dianah Fayas, Deputy Clerk-Treasurer Doreen Jackson, Road Patrolman Darin Ripp, Bill Acker, Jim Greiber, and Richard Acker.

Pledge of Allegiance was recited.

- 2. CONFIRMATION OF COMPLIANCE WITH OPEN MEETINGS LAW The Clerk confirmed that the agenda was posted at town hall and on the Town website.
- 3. INFORMAL PUBLIC COMMENT TIME - None.
- MINUTES OF PREVIOUS MEETING: June 6, 2023 Motion by Sup. Meinholz, seconded by Chairperson Pulvermacher to approve the minutes. Motion carried, 4-0.
- 5. CHAIRPERSON'S REPORT The chairman updated the board on state budget legislation and meetings he attended.
- DRIVEWAY PERMIT: 4951 PHEASANT BRANCH RD.

The applicant is upgrading the existing driveway to blacktop. There's no ditch or culvert; the applicant will work with the town road patrolman to design a ditch or swale as needed, to drain away from road.
